#### **RECOMMENDATIONS:**

That the Board of Supervisors adopt a resolution establishing a "15-Minute Parking" zone (7am-6pm) on Embarcadero Del Norte in the Isla Vista Area.

#### ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

#### **EXECUTIVE SUMMARY & DISCUSSION:**

Embarcadero Del Norte is a north-south major collector road in the Isla Vista Area. The segment of Embarcadero Del Norte that is the topic of this resolution is 37 feet-wide with fronting businesses and residences along its east and west sides. A request was received from the owner of a restaurant located on the west side of Embarcadero Del Norte north of Pardall Road asking that a 15-minute parking zone (7am-6pm) be established due to a high turnover of customers. This request is supported by the Isla Vista Foot Patrol. They will enforce the 15-minute parking and agree that it will improve the situation.

The Public Works Department recommends a 15-minute parking zone for the following location:

On the east side of Embarcadero Del Norte from a point 45 feet north of the centerline of Pardall Road to a point 195 feet north of the centerline of Pardall Road.
