SUBJECT: Set Hearing to Consider Response to the Grand Jury Report on "Los Prietos Boys

Camp/Academy, An Oasis of Hope."

Recommended Actions: That the Board of Supervisors:

a. Adopt the responses in Attachment (1) as the Board of Supervisors' responses to the 2006-07 Grand Jury Report entitled "Los Prietos Boys Camp/Academy, An Oasis of Hope, and

b. Authorize the Chair to sign the letter included in Attachment (1) forwarding the responses to the Presiding Judge.

Summary Text:

On May 22, 2007, the Civil Grand Jury released a report entitled "Los Prietos Boys Camp, An Oasis of Hope." The report includes eight findings and eight recommendations. The Board of Supervisors and the Probation Department are named as the Santa Barbara County government responders to the findings and recommendations.

It is recommended that the Board agree with the Findings 1, 2, 4, 5, 7 and 8, disagree with Finding 3 and partially disagree with Finding 6; and, further determine that Recommendations 1, 2, 3, 4, 5, 7 and 8 have been or will be implemented and Recommendation 6 will not be implemented. Details are outlined in Attachment (1). The Chief Probation Officer concurs with the recommended Board actions.

Background:

The Grand Jury Report was released on May 22, 2007. In accordance with California Penal Code Section 933(c), the governing body of the agency (Board of Supervisors) must respond within 90 days after issuance of the report. Consequently, the Board of Supervisors' responses must be finalized and transmitted to the Presiding Judge of the Superior Court no later than Tuesday, August 20, 2007.
