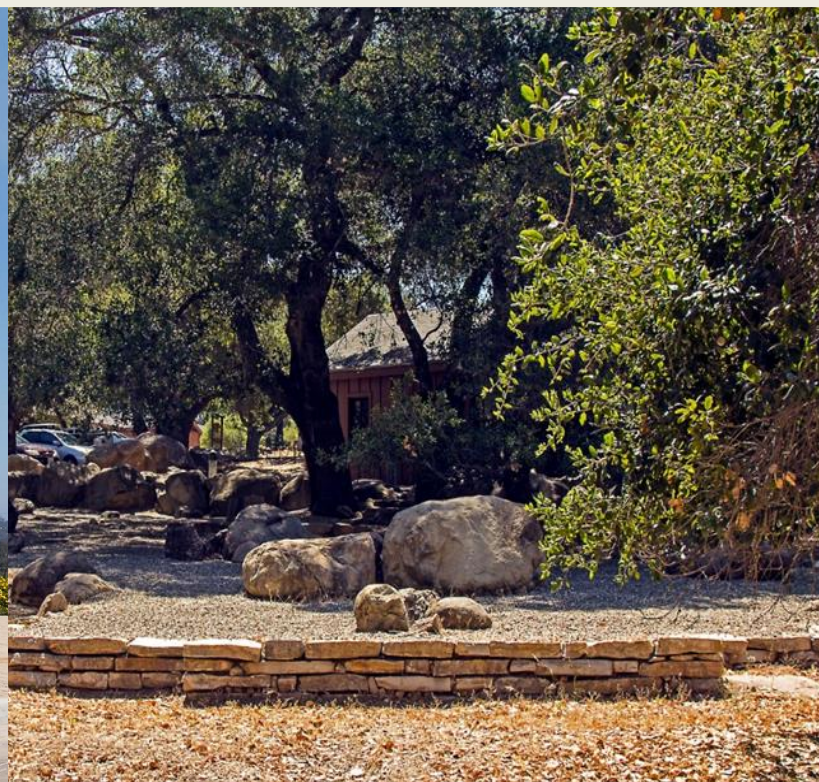

# COUNTY 1% FOR ARTS ORDINANCE HISTORY

Adopted in 1978 to:

- RECOGNIZE THE COUNTY'S RESPONSIBILITY TO FOSTER ARTS AND CULTURE
- SUPPORT LOCAL ARTISANS
- MAKE ARTS ACCESSIBLE TO THE GENERAL PUBLIC



# 1% FUNDING SUPPORTS:



## Permanant Capital Art

Long-term, building-grade art for integration into structures or permanant outdoor placement.



## Rotating Public Art

Sculpture and 2-D art in parks, plaza, and public areas.

Indoor art in County buildings and public spaces.



## County Gallery Exhibits

Rotatating exhibitions of works by local artists in North and South County; wall paint, patching, art transport, hanging, hardware and display.



## Maintenance and Repair

Repair of structural artwork, such as floor mosaic or murals, as well as damaged artworks and insurance costs, equipment rental, licensing, scaffolding, machinery.

# CURRENT PROCESS

All departmental requests to the Board for appropriations for individual capital projects must include 1% of the estimated cost for works of art.

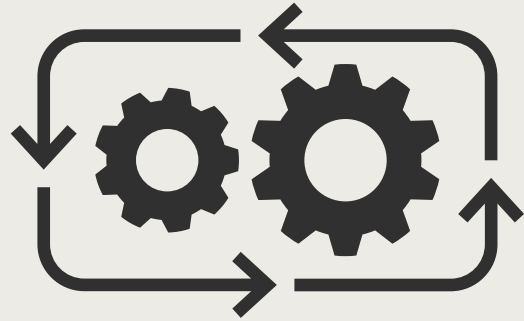
Upon each project's approval, the Board shall include an appropriation for art to be transferred to the County Arts Trust.

Calculation, tracking, and intradepartmental coordination have entailed significant administrative time.

# PROPOSED PROCESS IMPROVEMENTS

- Annual consolidated allocation
- 1% of the capital budget (not to exceed \$200,000 + CPI)
- A 25% set-aside will help offset program management costs
- Transferred to Arts Trust upon final budget adoption

# BENEFITS



## ADMINISTRATIVE EFFICIENCY

- Simplified departmental roles
- Multi-year project mapping
- Streamlined one-time allocation
- Addressing deferred maintenance



## GRANT READINESS

- Preparedness to respond to NoFAs
- Adaptive timeline
- Demonstration of funding match
