That the Board of Supervisors:

- A. Approve the attached, proposed Conflict of Interest Code of the San Antonio Basin Water District and
- B. Determine that the above action is an organizational or administrative activity of the government that will not result in direct or indirect physical changes in the environment and is therefore not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(5) of the CEQA Guidelines.

**Summary Text:**

The Board of Directors of the San Antonio Basin Water District adopted its Conflict of Interest Code on September 15, 2020. (See Attachment A—Resolution No. 20-08: Resolution Approving San Antonio Basin Water District’s Conflict of Interest Code and Attachment B—San Antonio Basin Water District’s Conflict of Interest Code.)

**Background:**

The Political Reform Act of 1974 requires every local government agency to:

1. Adopt a Conflict of Interest Code identifying the reporting requirements of covered employees,
2. Review the need for any changes to its code biennially, and
3. Submit an amended code to the “code reviewing body” if necessitated by changed circumstances. (Gov. Code §§ 87300, 87302, 87306.5, subd. (a).)

The Board of Supervisors is designated as the code reviewing body for independent districts and agencies with jurisdiction wholly within the County. (Gov. Code § 82011, subd. (b).) Once approved by your Board, the San Antonio Basin Water District’s proposed Conflict of Interest Code is deemed effective. (Gov. Code § 87303.)
