## **Recommended Actions:**

That the Board of Supervisors:

- Reappoint Joan Jamison, City of Solvang representative as well as at-large members Hans Duus and Ed Andrisek to the Indian Gaming Local Community Benefit Committee for the terms expiring on January 1, 2013, and;
- b. Appoint Richard Gomez, Vice Chairman of the Santa Ynez Band of Chumash Indians and Sam Cohen, Government and Legal Specialist to the Santa Ynez Band of Chumash Indians, to serve on the Indian Gaming Local Community Benefit Committee on an interim basis during the term expiring January 1, 2013.

#### **Summary Text:**

This item is before the Board to consider appointing new members to the Indian Gaming Local Community Benefit Committee ("Committee") on an interim basis and, in addition, reappoint the City of Solvang representative and the at-large members. These appointments of the tribal representatives are interim appointments to insure proper representation at the May 25<sup>th</sup> hearing of the Committee. It is anticipated that Chairman Armenta and Mr. Pagaling will be re-appointed as permanent members at a later date.

#### **Background:**

Senate Bill 621 and Assembly Bill 158 specify the composition of the Committee: two members from the Santa Ynez Band of Chumash Indians, two members from the County Board of Supervisors, one member from the City of Solvang and two at-large members, for a total of seven members. County staff

has met with staff from the Santa Ynez Band of Chumash Indians on this matter and representatives concur with the recommendations.

The primary purpose of the Committee is to award grants to mitigate the impact of tribal gaming on local governments.
