Recommended Actions:

- a) Approve, ratify, and authorize the Chair to execute the attached Fourth Amended Agreement for Professional Legal Services between the County of Santa Barbara and the Andruess/Podberesky law firm to increase the maximum contract amount by \$650,000 for a new maximum contract amount not to exceed \$1,950,000; and
- b) Determine that the above action is not a project under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Sections 15378(b)(4) and 15378(b)(5) because it consists of government administrative or fiscal activities that will not result in direct or indirect physical changes in the environment.

Summary Text:

On May 1, 2018, the Board executed an Agreement for Professional Services between the County of Santa Barbara and the Andruess/Podberesky law firm. The primary purpose of the contract was for Andruess/Podberesky to provide needed legal advice and representation in defending against False Claims Act litigation pending in the United States District Court in Los Angeles, California. Through this Fourth Amended Agreement, County Counsel recommends the Agreement be updated to increase the maximum contract amount.

For the past 3 years, Andruess/Podberesky has coordinated closely and effectively with County Counsel in meeting the demands of this highly specialized litigation. The increased maximum contract amount is estimated to continue to cover Andruess/Podberesky's fees and costs of discovery and mediation. The

County's excess insurer, PRISM, has confirmed that the costs of the County's representation by Outside Counsel in this matter will count toward satisfying the County's Self-Insured Retention.
