Recommended Actions:

That the Board of Supervisors approve and authorize the Chair to execute the first two (2) year extension contract for janitorial services with Service Master of Santa Maria, a local vendor.

<u>Summary Text:</u> The County has contracted with Service Master of Santa Maria since 1998 to provide janitorial services in the Santa Maria, Lompoc and Solvang areas and the company has proven during this time they are able to fulfill the tasks required.

Background:

In 2006, this contract was put out for competitive bid and again awarded to Service Master of Santa Maria to provide janitorial services to North County facilities for a period of three (3) years. During this three year period, Service Master has adequately fulfilled the requirements of the Agreement. Therefore, General Services is recommending that a two (2) year extension be approved as set forth in the Agreement. This extension will provide janitorial services to the 48 County Facilities (attached) for a period of two (2) years to begin July 1, 2009 and end June 30, 2011.

Due to recent agreements with the Superior Court of Santa Barbara County, General Services no longer provides janitorial services to Superior Court occupied areas at the following locations: the Santa Maria
