At the Planning Commission hearing of November 28, 2007, Commissioner Jackson moved, seconded by Commissioner Brown and carried by a vote of 3-2 (Blough/Valencia no) to not adopt the proposed Planning Commission Resolution and not support staff's recommendation that the Board of Supervisors:

- a) Adopt the Findings;
- b) Approve the Notice of Exemption; and
- c) Recommend that the Board of Supervisors approve a Resolution indicating that the County will consider rezones and/or general plan amendments in the SYVCP boundary that are consistent with the SYVCP and/or determined by the Planning Commission to be a public benefit.
