

Santa Barbara County COVID-19 By The Numbers


Cumulative Cases


Case Status


7-Day Rolling Sum of New Cases by Area


Adult COVID-19 Patients Hospitalized



ICU Capacity


Staffed Adult ICU Bed Availability





Santa Barbara County 7-day Average Community Test Positivity Percent



Health Officer Order: Allowable Today

Sector/Activity	Parameters
Private gathering	Limited to 3 households; outdoors only; masking & social distancing
Family Entertainment Centers	Open for outdoor operations @ 50%
Museum, zoos, aquariums	Open for outdoor operations
Restaurants; bars & wineries that serve meals	Open for outdoor operations
Miniature golf, go karts, batting cages	Open for outdoor operations @ 50%
Outdoor recreational activity	Open
Hotels, Motels	Tourism and individual travel allowed
Fitness facilities	Open for outdoor operations
Personal Care	Open at 25% indoor capacity
Faith-based services	Outdoor operations only
Indoor mall, shopping center, lower-risk retail	Open at 25% indoor capacity; food courts, and common areas closed
