WHEREAS, Title 3, Government of Counties, Division 3, Financial Provisions, Chapter 2. Funds, Article 12, Criminal Justice Administrative Fees, and Code Section 29550 have been amended;

WHEREAS, for the 2005-2006 fiscal year and each fiscal year thereafter, the fee imposed by a county pursuant to this subdivision shall not exceed ½ of the actual administrative costs, including applicable overhead costs as permitted by federal Circular A-87 standards;

WHEREAS, on June 17, 1997, this Board Adopted Resolution #97-255 imposing a criminal justice administrative fee pursuant to Government Code Section 29550 to reimburse the County for expenses incurred with respect to the booking or other processing of persons arrested by an employee of a city, special district, school district, community college district, college or university;

WHEREAS, effective January 1, 1997, Government Code Section 29550 requires the Board to set a booking fee prior to the beginning of the next fiscal year;

WHEREAS, this Board has conducted a noticed public hearing at which time it received and considered evidence relative to the increase of such fee; and,

WHEREAS, the Board finds it appropriate to impose a fee as authorized by Government Code Section 29550 and that the fee established by this Resolution does not exceed ½ of the actual booking costs.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Santa Barbara as follows:

1. The Criminal Justice Administrative fee is hereby imposed in the amount of \$ 99.58 for each person arrested and brought to County facilities for booking and detention by the aforementioned agencies. The amount of the fee does not exceed the actual costs, including any and all applicable overhead costs as permitted by federal Circular A-87 standards, incurred in booking or otherwise processing detained persons.

2. The fee is imposed upon a city, special district, school district, community college district, college or university for each person arrested by an employee of that entity and then brought to the county jail for booking or other processing from July 1, 2006 through June 30, 2007.

3. The Santa Barbara County Sheriff Department is authorized and directed to submit a monthly invoice to each entity listed in paragraph 2, above, reflecting the \$99.58 fee for all bookings on or after July 1, 2006 incurred by these agencies.

4. Except as modified by this Resolution, all terms and provisions of Resolution #91-79 remain in force and effect.
