SUBJECT: Resolution approving the application for grant funds for a project to fund development

of the Franklin Trail, Carpinteria Area, 1st District

Recommendation(s):

That the Board of Supervisors:

- 1. Adopt the attached resolution approving the filing of an application for grant funds for funding to design and develop the Franklin Trail from the Recreational Trails Program administered by the State Department of Parks and Recreation; and
- 2. Authorize the Director of Parks to act as agent for the County of Santa Barbara to conduct all negotiations, execute and submit all documents including, but not limited to applications, agreements, payment requests and so on which may be necessary for the completion of the project.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 5; A High Quality of Life for All Residents.

Executive Summary and Discussion:

This resolution authorizes County Parks to submit an application for funds to the Recreational Trails Program (non-motorized trails) under the federal Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU). The program is administered by the State of California Resources Agency Department of Parks and Recreation.

County Parks will request a grant for funding for the final design and development of the Franklin Trail to connect from the City of Carpinteria on County trail easements up to the US Forest Service, a distance of

approximately five miles to the federal land. It is not clear at this time if the grant program can also fund development on federal lands that would add an additional two miles up to East Camino Cielo at the ridge of the Santa Ynez range for development of an approximate seven mile trail. County Parks is in discussions with the State administering agency to determine the exact funding possibilities to determine if funding through this grant could also fund development on the US Forest Service property.

Mandates and Service Levels:

The public trail project is identified in the Parks, Recreation and Trails map (PRT-2) of the Comprehensive Plan. Once the trail is built County Parks, in association with other trail user groups, will provide maintenance services for the trail.

Fiscal and Facilities Impacts:

No fiscal impacts with this action. No impacts to facilities. This project is identified in the County's Capital Improvement Plan

- 4. Appoints the Director of County Parks as agent to conduct all negotiations, execute and submit all documents, including, but not limited to applications, agreements, amendments, payment requests and so on, which may be necessary for the completion of the Project.
- 5. Agrees to comply with all applicable federal, state and local laws, ordinances, rules, regulations and guidelines.
