- 2. Reappoint Patti Stewart Deputy Chief from the Probation Department as alternate "County Member" of the First 5 Children and Families Commission for the term of July 1, 2008 to June 30, 2009.

Summary Text:

Background:

First 5 Santa Barbara County, Children and Families Commission consists of nine regular and four alternate members appointed by the Board of Supervisors. One regular member of the Board of Supervisors and three regular members are "County Members" selected from among the County Health Officer, and the Director of Social Services, and the Director of Alcohol, Drug and Mental Health Services, and the Director of Probation. One permanent position on the Commission is the County Superintendent of Schools, and two members are from the "Community At Large". One Alternate

member is a member of the Board of Supervisors, one Alternate is a "County Member" and two Alternates are from the "Community at Large"

The Current regular "County Members" are Director of the PHD and Health Officer, Elliot Schulman, M.D., the Director of Social Services, Kathy Gallagher. The Director of Alcohol Drug, and Mental Health Services, James L. Broderick, PhD. served as Commissioner until his retirement in March 2007. Patti Stewart, Probation, serves as the Alternate "County Member. Performance Measure:

The members of the First 5 Children and Families Commission will be required to devote a substantial amount of time attending monthly Commission meetings, and evaluating future funding proposals, monitoring outcomes of existing grants, and ongoing Strategic Planning.
