Summary Text:

This item is on the agenda to formally begin appointing members to the new Behavioral Wellness Commission. Per the direction of the Board of Supervisors, at their regularly scheduled meeting of December 13, 2016, the Mental Health Commission (MHC) and the Advisory Board on Alcohol and Drug Problems (AOD) dissolve as of January 10, 2017. Correspondingly, the new integrated Behavioral Wellness Commission, created per Resolution No. 16-286, forms on January 10, 2017. Further staff was directed to advertise and solicit applications for members to serve on the Commission, and to bring appointments to the Board of Supervisors for consideration beginning January 10, 2017. This Board letter reflects the first in a series of appointments, recommended by members of the Board of Supervisors, for appointment to the new Commission. All applications are on file with the Clerk of the Board.

Background:

Behavioral Wellness Commission

As reported to the Board of Supervisors on December 13, 2016, in order to merge the MHC and the AOD, both existing entities needed to be dissolved and a new Behavioral Wellness Commission created. The dissolution process involved a formal action of the Board of Supervisors on December 13, 2016 to dissolve both bodies, through a resolution that also established the new Behavioral Wellness Commission. The Board of Supervisors indicated they would begin to appoint members to the newly established Commission in January, after reviewing applications.

Membership of a Behavioral Wellness Commission

- No more than 21 members, four per Supervisorial District (four regular members) and one member of the Board of Supervisors or designee. The designee would serve as a voting member in the Supervisor's absence.
- Representation shall recognize the geographic and cultural diversity of Santa Barbara County.
- 50% or more of the Commission of the total membership should be consumers or the parents, spouses, siblings, or adult children of consumers who are receiving or have received mental health services, such that:
 - i. At least 20% of the total membership shall be consumers of mental health services; and
 - ii. At least 20% of the total membership shall be family members of consumers of mental health services.
- Commission members shall have a professional interest in, or personal commitment to, alleviating problems related to mental illness, drug abuse and inappropriate alcohol use in their community, and experience and knowledge of the behavioral health system.
- It is preferred that the Board of Supervisors appoint individuals from within their Supervisorial district, however, in order to meet the statutory requirements for the Commission, appointees from outside of one's District may be considered.
