**RESOLUTION OF COMMENDATION FOR SHERIFF'S DEPUTY, SPECIAL DUTY  
VINCENT RAY BUCK UPON HIS RETIREMENT FROM THE SHERIFF'S OFFICE**

**WHEREAS**, Vincent Buck will be retiring from County service on Sunday, February 23, 2025, having faithfully served the Sheriff's Office and the communities of Santa Barbara County. Vincent Buck had previously served in as a Deputy Sheriff in the Tulare, Lassen and San Luis Obispo Counties, during which he served as a Sheriff's Custody Deputy, a Resident Deputy, a Uniformed Gang Detective, a Motor Officer, an undercover Gang/Narcotics Detective, a Recruit Training Officer, a Bailiff and a Patrol Senior Deputy; and

**WHEREAS**, Vincent Buck started his career with Tulare County on June 30, 2002, as a Custody Deputy in the Main Jail located in Visalia. During his twenty-two ½ years of service, he has worked in various capacities which included Detentions and Corrections, Patrol, Motor Unit, Training Bureau, Court Services, and Special Investigations; and

**WHEREAS**, Vincent Buck, throughout his career, provided the employees of the Sheriff's Office positive leadership and professionalism, allowing him to excel in his assigned duties in the various agencies attaining the rank of Senior Deputy; and

**WHEREAS**, Vincent Buck provided the citizens of Santa Barbara, Tulare, Lassen and San Luis Obispo Counties extraordinary professionalism and sensitive law enforcement service while dedicating his life to the pursuit of justice; and

**WHEREAS**, Vincent Buck's knowledge, skills and experience contributed greatly to the overall professionalism and the goals of the Santa Barbara County Sheriff's Office as well as the objectives of the County.

**NOW, THEREFORE, BE IT HEREBY ORDERED AND RESOLVED** that the Board of Supervisors of the County of Santa Barbara does hereby acknowledge this Resolution of Commendation for Sheriff's Deputy, Special Duty Vincent Ray Buck upon his retirement from the Santa Barbara County Sheriff's Office.
