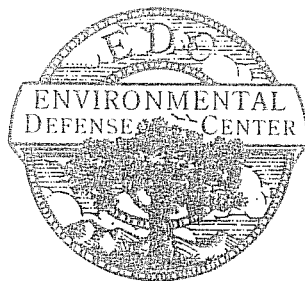

Re: Supervisor Firestone's Conflict of Interest in the Uniform Rules Update – The Proposed Update Does Not Affect the "Public Generally."

Dear Mr. Stark:

I am writing to provide additional evidence regarding Supervisor Firestone's conflict of interest in the County's proposed Uniform Rules Update, now scheduled for consideration by the Board of Supervisors on February 13, 2007. As we discussed during our December 21, 2006 telephone conversation, I am requesting that this information be provided, along with our December 18, 2006 letter, to the Fair Political Practices Commission (FPPC) as they consider Supervisor Firestone's conflict of interest in this matter.

As you know, California law states that "[n]o public official at any level of state or local government shall make, participate in making or in any way attempt to use his official position to influence a governmental decision in which he knows or has reason to know he has a financial interest." Cal. Govt. Code § 87100. "A public official has a financial interest in a decision within the meaning of Section 87100 if it is reasonably foreseeable that the decision will have a material financial effect, *distinguishable from its effect on the public generally*, on the official, a member of his or her immediate family," on any business entity or real property "in which the public official has a direct or indirect investment worth two thousand dollars (\$2,000) or more," or "any business entity in which the public official is a director, officer, partner, trustee, employee, or holds any position of management." CA Govt. Code § 87103 (*emphasis added*).

We understand that Supervisor Firestone and his family have at least 573 acres of land enrolled in the Williamson Act program. The proposed changes in the Uniform Rules Update would increase the potential for new residential, commercial and industrial development on Supervisor Firestone's property, and allow several new uses that are prohibited under the current rules. We want to emphasize that even if Supervisor Firestone does not *actually* take advantage of these rule changes, the increased development potential and newly enhanced allowable uses of his land will serve to increase the market value of that property since subsequent owners can take advantage of the changes.

In this letter, we will focus on the portion of the conflict of interest analysis concerning whether the proposed legislation affects the “public generally,” or a more narrow interest group. We will present specific facts that, when applied to the relevant law, demonstrate that the proposed changes in the Uniform Rules Update do not affect the public generally.

**A. “Public Generally” and “Significant Segment”**

The proposed amendments to the Uniform Rules would not affect all residents, or even all landowners, in Santa Barbara County. The Rule changes will only affect the individuals and agricultural property involved in Williamson Act contracts. Thus, the changes do not affect the general public. The next question is whether the proposed changes would affect a “significant segment” of the general public.

In general, the FPPC requires a group of people to be large in number and heterogeneous in nature for it to qualify as a significant segment of the public. *In re Overstreet* 6 FPPC Ops. 12 (1981); *In re Ferraro* 4 FPPC Ops. 62 (1978). To the extent the group affected by the proposed legislation reflects only a narrow interest within the County, it is not considered a significant segment of the general public. Cal. Atty. Gen. Indexed Letter, No. IL 75-58 (April 8, 1975); *In re Brown* 4 FPPC Ops. 19 (1978); *In re Legan* 9 FPPC Ops. 1 (1985).

The FPPC has established a four-part test, including specific numerical thresholds, for determining when a group of people constitute a “significant segment” of the public.

Step 1: Identify the People and Property Affected by the Governmental Decision

Through this proposed legislation, the County is proposing to change its “Uniform Rules.” The Uniform Rules define the allowable uses for land enrolled in the County’s Agricultural Preserve Program (also known as the Williamson Act program). Thus, the governmental decision will only affect agricultural land owners, and agriculturally zoned land, that are involved in a Williamson Act contract with the County. (Attachment A – County Williamson Act contract holders and parcel numbers.) According to the County’s proposed Final Environmental Impact Report on the Uniform Rules Update (EIR), there are 2,230 parcels under contract in Santa Barbara County, owned by 1,247 contract holders. (Attachment B – Uniform Rules Update EIR page 3-4.)

Step 2: Determine the Applicable “Significant Segment” Rule

According to California Code of Regulations section 18707.1, the governmental decision will affect a “significant segment” of the public generally if certain thresholds pertaining to any of the following are affected: individuals’ finances, real property, business entities, or governmental entities.

Step Three: Determine if the Significant Segment is Affected by the Decision

(a) Individuals.

For decisions that affect the personal expenses, income, assets, or liabilities of a public official or a member of his or her immediate family, the decision also affects:

(i) Ten percent or more of the population in the jurisdiction of the official's agency.<sup>1</sup> According to the County website, the County's population is approximately 410,000. Thus, ten percent of the population is 41,000. With only 1,247 contract holders affected by the proposed Uniform Rules amendments, the legislation does not affect 10 percent or more of the population.

(ii) Five thousand individuals who are residents of the jurisdiction. Again, the EIR states that the proposed Rule change will only affect the 1,247 Williamson Act contract holders enrolled in the County's Agricultural Preserve Program. That number also falls short of the "5,000 residents" requirement.

(b) Real Property.

For decisions that affect a public official's interest in real property, the decision also affects:

(i) Ten percent or more of all property owners in the jurisdiction of the official's agency. According to the County Assessor's office, there are 126,900 parcels in Santa Barbara County. Thus, ten percent of all property owners in the County equals roughly 12,690.<sup>2</sup> As indicated above, the decision only affects the 2,230 parcels and 1,247 property owners enrolled in Williamson Act contracts, which represent between one and two percent of properties or property owners in Santa Barbara County.

(ii) 5,000 property owners in the jurisdiction of the official's agency. Again, the 1,247 property owners enrolled in the Williamson Act program, who are affected by this decision, fall below the "5,000

<sup>1</sup> Because the proposed Uniform Rules changes affect all of the contracted agricultural land in Santa Barbara County, we will define the jurisdiction of the Board of Supervisors as the County boundaries.

<sup>2</sup> The Assessor's office was able to identify the number of parcels in the County, but unable to determine the exact number of property owners. Clearly, some individual property owners own multiple parcels. According to the Uniform Rules Update EIR for example, there are 2,230 parcels enrolled in 1,247 individual contracts in the County's Agricultural Preserve Program. (Attachment B.)

property owners” requirement. Thus, the decision does not meet this criterion either.

(c) Business Entities.

For decisions that affect a business entity in which a public official has an economic interest, the decision also affects either 2,000 or twenty-five percent of all business entities in the jurisdiction, so long as the effect is on persons composed of more than a single industry, trade, or profession.<sup>3</sup>

The proposed Uniform Rules changes only apply to Williamson Act contracted land. The Williamson Act is designed to protect agricultural lands so that they remain available for agricultural production. These proposed Rule changes are designed to increase development potential, flexibility, allowable uses, and income sources for Williamson Act contract holders. Thus, the changes are intended to benefit only one industry – agriculture. As a result, this section does not apply.

Furthermore, the decision does not affect 2,000 or 25 percent of all businesses in the County. According to the UCSB Economic Forecast Project (citing fourth quarter 2005 data from the Employment Development Department), there are 13,158 business entities in Santa Barbara County. Twenty-five percent of that number is 3,290. Since the decision only affects the 1,247 Williamson Act contract holders in Santa Barbara County, this section does not apply.

Since none of the “significant segments” are affected by the Board of Supervisors’ decision regarding the Uniform Rules Update, the analysis ends because the first prong of the two-part test set forth in 2 Cal. Code Regs. section 18707.1(b) is not met, and Supervisor Firestone cannot participate in the governmental decision. Moreover, since there is no significant segment affected by the Rules changes, the analysis need not reach Step Four.

**B. Industries, Trades, and Professions**

With respect to County elected officials, the regulations state that “an industry, trade, or profession constitutes a significant segment of the public generally if that industry, trade, or profession is a predominant industry, trade, or profession in the official’s jurisdiction.” 2 Cal. Code Regs. § 18707.7 (b). A “predominant industry” is defined as an industry that constitutes fifty percent or more of business entities in the jurisdiction of the official’s agency. *Ibid.* As noted above, there are approximately 13,158 businesses in Santa Barbara County. Thus, a “predominant industry” would be an industry consisting of more than 6,579 businesses. According to State and County data, there are less than 1,000

<sup>3</sup> For purposes of this subdivision, a not for profit entity other than a governmental entity is treated as a business entity.

agricultural businesses in Santa Barbara County. (Attachment C – “Counting California” data.) Furthermore, County records claim that the agricultural industry constitutes less than five percent of the County’s workforce. (Attachment D – County Statistical Profile.) Thus, although agriculture is a critical component of Santa Barbara County’s economy, culture, and quality of life, it does not meet the state’s definition of “predominant industry” and, therefore, does not constitute a “significant segment” of the public.

### **C. Conclusion**

The proposed amendments to the County’s Uniform Rules apply only to a very limited segment of the individuals, landowners, and business entities in Santa Barbara County. The legislation does not apply to a significant segment of the public generally. Supervisor Firestone and his family are in the top 20% of landowners in the County in terms of acres of land in Williamson Act contract. As such, he will derive a unique and specialized economic benefit from these rule changes unlike most other residents of Santa Barbara County. The law requires Supervisor Firestone to recuse himself from any participation in this matter.

# ATTACHMENT B

## **Agricultural Regions of Santa Barbara County**

Approximately 52 percent of Santa Barbara County is privately owned land (855,000 acres), with close to 90 percent of this land zoned for agriculture. As of September 2005, there were 2,230 assessor's parcels enrolled in 1,247 individual contracts in the County's Agricultural Preserve Program, encompassing approximately 555,000 acres throughout the County. Agricultural parcels range in size from 5 acres up to over 30,000 acres (County Assessor's Office, 2005). Lands enrolled in the Agricultural Preserve Program represent the full array of agricultural operations in the County. Enrollment in the Agricultural Preserve Program helps to ensure the continuation of these agricultural lands by providing a tax incentive to stay in agricultural production.

For planning purposes, the Board of Supervisors defined eight distinctive rural regions: 1) South Coast, 2) Gaviota North Coast, 3) Gaviota Coast, 4) Santa Ynez Valley, 5) Lompoc Valley, 6) San Antonio Creek, 7) Santa Maria Valley, and 8) Cuyama Valley. Each supports its own mix of agricultural production determined primarily by the area's climate, soils, topography and hydrology. Below is a general description of the agricultural lands in each of the Board-designated rural regions throughout the County. The statistics provided below are current as of September 2005 and summarized in Table 2-1.

South Coast (106,000 acres): Agriculture along the South Coast, from Goleta to Carpinteria, is primarily made up of smaller parcels (i.e. prime and superprime categories) engaged in high value irrigated crops, such as tropical and sub-tropical fruit orchards and flowers. The moderate year-round climate and productive alluvial soils make for highly productive agricultural operations, even on the smaller parcels. In addition to the region's orchards and open field agriculture, the Carpinteria Valley produces more than half of the County's cut flower and nursery products. Chrysanthemums, orchids, roses, and potted plants grown in 400 acres of greenhouses in and around the City of Carpinteria contribute a significant amount to the County's agricultural economy. Avocados, as well as exotics such as sapotes and cherimoyas, are grown on the hillsides north of the urban area. Agricultural lands in this region are continually faced with development pressures from the adjacent and surrounding urban areas and the extremely high land values found in the region. Enrollment in the Agricultural Preserve Program helps to ensure the continuation of these agricultural lands by providing a tax incentive to stay in agricultural production. Close to 50% of the agriculturally-zoned land in the region are enrolled in the Agricultural Preserve Program, primarily in the Carpinteria and Goleta valleys. Specifically, there are 166 individual contracts within this region, representing 10,900 acres of which 5,380 are nonprime acres and 5,520 acres are in prime and superprime contracts.

Combined Gaviota Coast and North Gaviota Regions (94,000 acres): Land in the North Gaviota Coast Region (43,000 acres) is predominantly owned by the Bixby and Hollister ranch companies. The primary land use in this agricultural region is cattle grazing. The Hollister Ranch is made up of over 100 parcels each of 100 acres or more in size. Many of the properties participate in a cooperative grazing operation that utilizes land spread over the entire ranch; other properties are involved in low intensity agricultural uses to meet the minimum requirement for enrollment in the Agricultural Preserve Program. 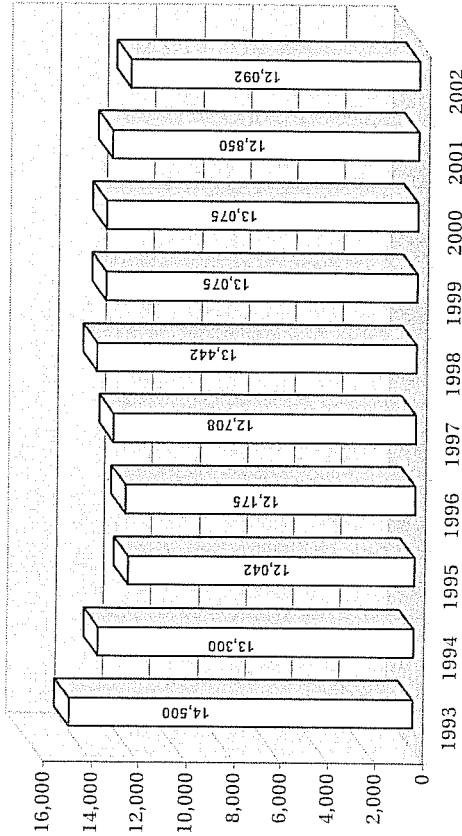

Durable manufacturing and utilities define the industrial sector. During 2002, the industrial sector employed an average of 12,092 workers. This employment represents 6.9% of all non-farm wage and salary jobs in the County. The manufacturing industries have lost 2,408 jobs since 1993, due primarily to high technology industries dependent upon U.S. and international electronics demand. During 2002, the industry experienced a decrease of 758 jobs.

Industrial Sector Employment



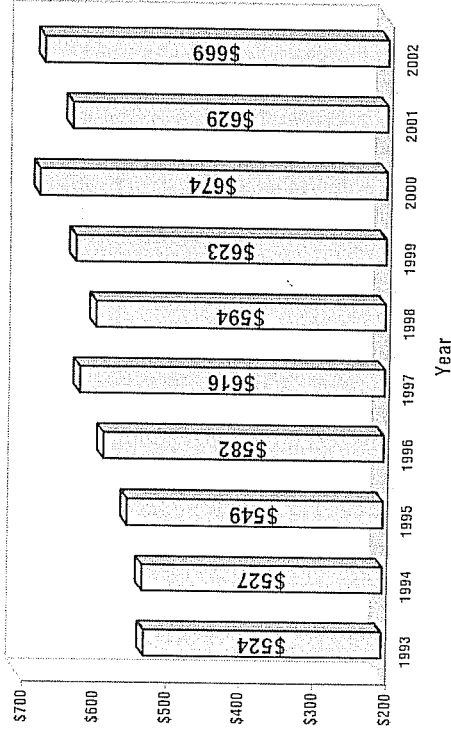

**Agriculture**

Sales of agricultural products grown in the County was \$669 million in 2002, a 6.4% increase from 2001 and a positive change from the prior year's negative growth rate of 6.7%. In 2002, acres devoted to agriculture remained essentially the same as 2001 with a slight dip of .04%. Due to a 20% increase in harvested acres, strawberries were the County's number one crop in 2002 with a record value of \$115.8 million. Broccoli followed strawberries as the number two crop and wine, 2001's number one crop, fell to third place. Wine grapes in 2002 experienced a lower yielding, but higher quality, season. Accordingly, despite the lower yields, prices for the County's wine grapes increased.

Acres devoted to the county's principal crops decreased by 3.1%. Earnings per acre, increased by 6.4%, to \$5,802 in 2002. The farming sector employed an average of 12,708 workers in 2002, which accounted for 3.3% of all wage and salary employment in the County. The agricultural sector lost a net of 800 jobs in 2002, which is a decrease of 5.9% from 2001. Salaries in 2002 for farm related production and service labor averaged \$19,161, a 6.1% increase over 2000.

(in 1996 Dollars)



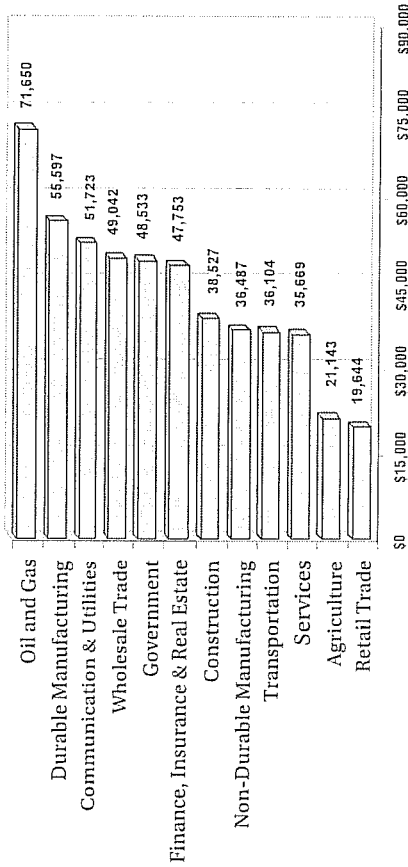

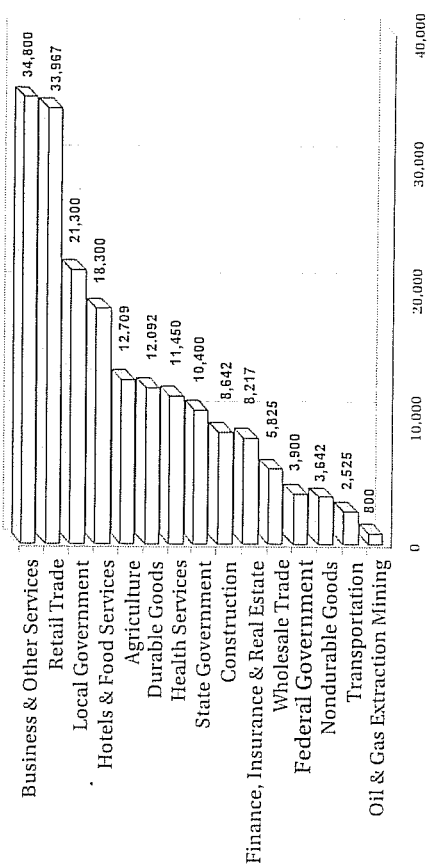
