 AWARENESS DAY IN SANTA BARBARA COUNTY

WHEREAS, October 24<sup>th</sup>, 2016 is recognized as "Food Awareness Day" which is a time to educate and inform our community about the benefits of eating healthy and nutritious foods; and

WHEREAS, Food Awareness Day is a nationwide celebration of healthy, affordable, and sustainably produced food and a grassroots campaign for better food policies. It builds all year long and culminates on October 24<sup>th</sup> with events that promote the health benefits of reducing consumption of sugary drinks, overly salted packaged foods, and fatty, factory-farmed meats in favor of vegetables, fruits, whole grains, and sustainably raised protein; and

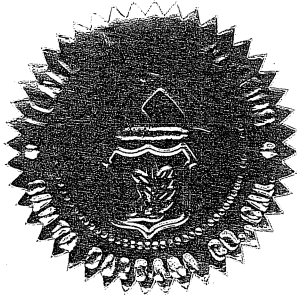

WHEREAS, Food Day challenges individuals and communities across the country to change our diets and our food policies in the effort to improve public health and reduce impacts from diseases associated with unhealthy eating habits; and

WHEREAS, Food Day is a partnership with many public and community based organizations including the County Public Health Department, the Community Action Commission, the Foodbank of Santa Barbara County, Fairview Gardens, Harvest Santa Barbara, IV Food Coop, Chapala Gardens and the Santa Barbara County Master Gardeners;
