Modernization of the existing elevator controls and fixtures with new and upgrading the cab interiors are minor alterations to the existing facility. The project is categorically exempt from the provisions of CEQA pursuant to Sections 15301, subdivisions (a) (minor alterations to existing facilities) of Title 14 of the California Code of Regulations and Section 15302 (replacement and reconstruction). The modernization of the existing elevator controls and upgrading the cab interiors is located on the same site, will have the same

purpose as the existing elevators, involves negligible or no expansion of capacity, and will serve existing uses of the site. The exceptions to this Categorical Exemption do not apply because there are no mapped resources in the project area, no cumulative impact, no significant effect due to unusual circumstances, no visible scenic highway, the site is not listed on list compiled to Section 65962.5 of the Government Code, and the building is not a historical resource.
