SUBJECT: County of Santa Barbara Racial Equity Grant Program Award Disbursement

Recommended Actions:

- a) Receive and file an interim report from Fund for Santa Barbara, Inc. ("The Fund") regarding its administration of the County's Racial Equity Grant Program and grant award recommendations.
- b) Approve and authorize The Fund for Santa Barbara to disburse the County of Santa Barbara's Racial Equity Grant Program funds to selected applicants (Attachment A) through June 30, 2025, and in accordance with the Regranting Agreement between the County and The Fund, executed on November 7, 2023.
- c) Determine that the recommended actions are not a project subject to the California Environmental Quality Act under CEQA Guidelines section 15378(b)(5), because they consist of administrative activities that will not result in a direct or indirect physical change to the environment; and CEQA Guidelines section 15378(b)(4) because they consist of government fiscal activities that do not involve any commitment to any specific project which may result in a potentially significant impact on the environment.

Summary Text:

This item is before the Board of Supervisors (Board) to approve and authorize the Fund for Santa Barbara, Inc. ("The Fund") to enter into contracts disbursing Racial Equity funds to the seven recommended grant applicants listed in Attachment A. Individual grant award amounts range from \$7,500 to \$60,000 for one year. The funding available for this program is \$275,000, which was appropriated by the Board during the FY 23-24 Budget Hearings.

The County of Santa Barbara Racial Equity Grant Program is aimed at effecting the culture, policy, and systems changes necessary to advance racial equity and justice. The program provides funding to invest in and strengthen organizations that actively support anti-discrimination, as well as communities marginalized by power structures.

Background:

At the June 16, 2023 budget hearings, the Board unanimously authorized a \$275,000 appropriation of funds to be disbursed through an equity grant cycle administered by The Fund. On November 7, 2023, the Board approved the contract with The Fund to administer the grant program (Attachment B). The contract included the condition that final award recommendations be presented to the Board for final approval prior to The Fund entering into contracts with selected grantees.

The Fund released a request for proposals on November 13, 2023, and offered a corresponding informational workshop. The applications were received and reviewed by The Fund's Grant Making Subcommittee, and final recommendations were approved by The Fund's Board of Directors on February 11, 2024. Upon Board of Supervisors approval, The Fund will enter into grant agreements with the seven selected recipients (Attachment A). Grant award amounts range from \$7,500 to \$60,000 and will be for one year. All funding must be disbursed no later than June 30, 2025.

For fulfillment of the contract, The Fund is receiving an administrative fee of \$41,250, which will be deducted from the \$275,000 in equity funds. The first administrative payment of \$18,563 has been issued. It encompassed the following work items: announcing the grant program; holding grant workshops; receiving application submissions; compiling summaries of the applications; and disseminating submissions to reviewers. A second administrative payment of \$18,562 will be issued upon the Board's approval of The Fund's grant recommendations as well as the County's receipt of an interim report (Attachment C) providing an update on the status of the previous grant cycle's projects. This payment will also include the \$233,750 regranting allocation, which The Fund will disburse directly to grantees. The third and final installment of \$4,125 will be paid to The Fund following disbursement of all regranting funding and the completion of a final report, which will include reports from the grantees.

Organizations Recommended for Funding:

For the Racial Equity Grant Program, \$233,750 in funding was available, and the maximum request amount was \$100,000. Twenty organizations submitted applications, requesting a total of \$1,248,130. Seven organizations were recommended for grant awards by The Fund: C4 Collective Cultures Creating Change-Lompoc, NAACP Santa Barbara, One Community Action of Santa Maria Valley, Santa Barbara Asian American Pacific Islander Solidary Network, Martin Luther King, Jr. Committee, Santa Barbara, Healing Justice Santa Barbara, and Gateway Educational Services.
