SUBJECT: **Continuous Deflective Separation (CDS) Project Completion, First, Second, and Third Supervisorial District**

Recommendation(s):

That the Board of Supervisors:

- A. Accept the attached Notice of Completion for the Continuous Deflective Separation (CDS) Project and authorize the Clerk to record; and
- B. Adopt the Resolution establishing the final quantities for work performed and materials supplied for the CDS Project by the contractor Granite Construction (a local vendor) in the amount of \$383,228.98.

Executive Summary and Discussion:

On November 26, 2002, your Board entered into an agreement with Granite Construction for the CDS Project in the amount of \$373,175.00.

The project consisted of installing storm water quality treatment facilities at four separate locations within Santa Barbara County. The CDS units were installed at the following locations:

- San Vicente Drive & Walnut Lane in unincorporated Goleta
- San Vicente Drive & San Ramon Drive in unincorporated Goleta
- El Embarcadero Drive & Del Playa in Isla Vista
- 6th Street in the City of Carpinteria

The County has accepted the work of the contractor, Granite Construction completed per plans and specifications. The project was completed at a cost of \$383,228.98.

Mandates and Service Levels:

Water quality improvement efforts have been the goal of Project Clean Water. This pilot project will not only remove pollutants from storm water runoff, but will also provide a local example of appropriate technology that can be used in areas of new development or existing development. Information on installation, maintenance, and overall effectiveness will be used for potential future projects, and will help our community address pollution concerns over storm water runoff.

Fiscal and Facilities Impacts:

This is the continuation of a series of projects funded through the State of California. The funding is provided as part of an existing \$2.1 million grant agreement with the California Coastal Conservancy. This grant is being used to fund a number of similar projects along the South Coast treating water pollution associated with storm water runoff. A resolution agreeing to the terms and conditions of the grant agreements and authorizing the Public Works Director to enter into each agreement with the Coastal Conservancy to receive these funds was approved by your Board on November 14, 2000.

This project is included in the 2003-04 Adopted Budget in the Water Agency cost center of the Water Resources Division as shown on page D-322 of the budget book. The costs associated with this project will be paid from Dept: 054, Fund: 3060, Acct: 8200, Program: 3008. Long-term maintenance of the CDS units will be funded by Project Clean Water and will be included each year in the Water Agency cost center of the Water Resources Division budget.
