Title: Transfer Countywide Security Contract Budget to General Services.

Budget Action: Incr approps of \$1,200,000 in General Services General Fund for Services & Supplies funded by an Intrafund Expenditure Transfer (-) from the General Fund. Decr

approps of \$1,200,000 in General County Programs General Fund for Other Financing Uses offset by a decr in Intrafund Expenditure Transfer (-). Decr budgeted revenues of \$1,200,000 in County Executive Office Workers' Comp Self Insurance Fund in Other Fin Sources offset by a dec of approps in Services & Supplies.

Justification: This BJE transfers appropriate budget in the amount of \$1,200,000 to the General Services department to administer the contract with Triumph Protection Group for

security services provided countywide. General Services previously managed this agreement in FY 24/25 but transferred responsibility to the Risk Division of the CEO's office at the time the Security Coordinator transferred. In the FY 2025-26 adopted budget, this security contract was funded by General Fund Contribution (GFC) that was received by the General County Programs General Fund with a budgeted operating transfer to the CEO Risk Management Division. This BJE will transfer GFC back to

General Services as this countywide contract is more appropriately budgeted and administered in the General Fund General Services department.
