Attachment B: Ordinance amending Chapter 20 of the Santa Barbara County Code (including mark-up)

MARK-UP VERSION OF

AMENDING CHAPTER 20 JUVENILES OF THE SANTA BARBARA COUNTY CODE TO REPEAL ARTICLE III SECTIONS 20-9 THROUGH 20-13 AND ARTICLE IV SECTIONS 20-14 THROUGH 20-16.

SECTION 1: ORDINANCE AMENDMENT TO CHAPTER 20, ARTICLE III.

Santa Barbara County Code Chapter 20, titled Juveniles, Article III Los Prietos Boys Camp, sections 20-9 through 20-13 is hereby amended as follows:

Sec. 20-9. Established.

A Juvenile Forestry Camp is hereby established at Los Prietos in the county, such campt to be known as "Los Prietos Boys Camp."

Sec. 20-10. To be jointly operated with Ventura County.

The camp established by the preceding section shall be jointly operated by the Counties of Ventura and Santa Barbara.

Sec. 20-11. Superintendent to be appointed; rules and regulations.

The camp shall be in charge of a superintendent, who shall be selected by the board of directors of the camp. The duties of the superintendent shall be prescribed by, and his activities, orders, rules, regulations and administration of the camp shall be subject to the authority, approval, and direction of the board of directors of the camp.

Sec. 20-12. Board of directors to manage camp; composition of board; quorum.

The internal affairs and administration of the juvenile forestry camp shall be under the management and control of a board of directors consisting of the probation officers of Ventura and Santa Barbara Counties, the judges of the Superior Courts of Ventura and Santa Barbara Counties and the county superintendent of schools of the county who shall operate the school maintained at the camp, all of whom shall hold office by virtue of and during the term of their official positions. In addition, the board of supervisors of Ventura and Santa Barbara Counties shall select one member of each board to serve as a director at the pleasure of each of the boards of supervisors, and the juvenile justice commissions of Ventura and Santa Barbara Counties shall each select one of its members to act as a director at the pleasure of each of the juvenile justice commissions. In addition, the boards of supervisors of each county shall appoint one person who is not connected in any way

with any branch or department of county government to the board of directors, to represent the general public on the board of directors, such person to serve at the pleasure of the board of supervisors which appointed that person. Five (5) members of the board of directors shall constitute a quorum for the transaction of business.

Sec. 20-13. Finances to be pursuant to written contract.

The method and procedure of financing the camp, and the details of the joint operation thereof shall be established by written contract between the respective boards of supervisors.

SECTION 2: ORDINANCE AMENDMENT TO CHAPTER 20, ARTICLE IV.

Santa Barbara County Code Chapter 20, titled Juveniles, Article IV Counseling and Educational Centers, sections 20-14 through 20-16 is hereby repealed as follows:

Sec. 20-14. Names and locations.

There is hereby maintained and continued in existence pursuant to the provisions of sections 654, 725, and 727 of the Welfare and Institutions Code, those institutions formerly created and established pursuant to the provisions of sections 880 through 891, inclusive, of the Welfare and Institutions Code, and heretofore designated as "juvenile day care homes" which shall all be known and designated as "counseling and education centers," as follows:

"Villa Esperanza" in the Santa Barbara area.
"Casa Floral" in the Lompoc area;
"Camino Segundo" in the Santa Maria area.

The exact locations of the foregoing counseling and educational centers shall be as specified by resolution of the board of supervisors.

The counseling and educational centers shall be operated in accordance with applicable standards therefor, published by the Youth Authority of the State of California.

Sec. 20-15. Management.

The internal affairs of such counseling and education centers shall be under the management and control of the county probation department. All counseling and educational centers shall be in the charge of a director, who shall be selected and appointed under the county civil service regulations by the chief probation officer, subject

to confirmation by the board of supervisors. All other personnel at such counseling and education centers are subject to the county's civil service regulations and shall be selected and appointed by the chief probation officer, subject to confirmation by the board of supervisors.

Sec. 20-16. Schools

Pursuant to the provisions of section 889 of the Welfare and Institutions Code, the county superintendent of schools is hereby authorized and directed to establish and maintain a public school at each of the counseling and education centers established hereby, and other juvenile intuitions of such grade or grades as may, in judgment of the county superintendent of schools, be necessary.

SECTION 3: PARTS NOT EFFECTIVE.

Except as amended by this Ordinance, the Santa Barbara County Code shall remain unchanged and shall continue in full force and effect.

SECTION 4: SEVERABILITY.

If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this Ordinance. The Board of Supervisor hereby declares that it would have passed this Ordinance and each section, subsection, sentence, clause, and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses, or phrases be declared invalid.

SECTION 5: PUBLICATION AND EFFECTIVE DATE.

This Ordinance shall take effect and become operative 30 days from the date of its adoption by the Board of Supervisors. In compliance with Government Code section 25124, within 15 days after its passage, a summary of the ordinance shall be published once, together with the names of the members of the Board of Supervisors voting for and against the same in the, Santa Barbara Independent, a newspaper of general circulation published in the County of Santa Barbara.
