Title: Establish Appropriations for Additional ERP Staffing and Vendor Services

Budget Action: Establish approp of \$1.815M in Gen Co Progs G/F for Intrafund Expend Txfrs Out (\$1.765M) and S&S (\$50K) funded by release of Co ERP Project Fund Balance; inc

approp for S&B (\$498K) and S&S (\$200K) in the A-C G/F, inc approp for S&B in the HR G/F (\$484.2K), and inc approp for S&B in the IT G/F (\$672.8K) funded by Intrafund Expend Txfrs In from the Gen Co Progs G/F, and dec approp for S&B in the GS G/F (\$89.5K) and reduce Intrafund Expend Txfr In from Gen County Progs G/F.

Justification: The Workday ERP System will include most of the County's finance, payroll, human capital, and budget applications. A-C, HR, and IT are responsible for countywide

support and are heavily impacted by the level of staff effort necessary to implement and support the Workday ERP System.

A-C is requesting funding for one manager, two Financial Systems Analysts, and one Financial Accounting Analyst to staff the A-C Workday Support Division. HR is requesting three Team/Project Leader positions and one Admin Office Pro position to backfill staff dedicated to the project along with funding for a temporary pay increase. IT is requesting one Program/Business Leader, two EDP Sys & Prog Analyst Sr, one EDP Office Auto Spec I, and one Computer Systems Spec II to serve as the Technical team for the Workday Support Team. Funding provided to GS in the FY 23-24 Adopted Budget for the Procurement Lead for the fiscal year is being reduced to the amount needed for half of the fiscal year due to the anticipated completion of Phase 1 by December 2023.

A-C is also requesting funding for vendor services (\$200K) to support data conversion and payroll implementation. An additional \$50K of funding is also being requested in Gen County Progs for vendor services anticipated for integrations and/or training content development.

These costs will be funded through one-time use of the Gen County Progs G/F Countywide ERP Project fund balance. Departments will be reimbursed based on actual
