#### FIRST AMENDMENT 2013-2014

#### TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

This is an amendment (hereafter referred to as the "First Amended Contract") to the Agreement for Services of Independent Contractor, referenced as number <u>BC 14-112</u>, by and between the **County of Santa Barbara** (County) and **TriWest Group, LLC** (Contractor), for the continued provision of consulting services.

Whereas, Contractor represents that it is specially trained, skilled, experienced and competent to perform the special services required by County and County desires to retain the services of Contractor pursuant to the terms, covenants, and conditions referenced herein.

Whereas, this First Amended Contract incorporates the terms and conditions set forth in the contract approved by the County Board of Supervisors in June 2013, except as modified by this First Amended Contract.

Whereas, County anticipates that Contractor will provide, at the request of County, a greater number of services than contemplated by the original Agreement, and will incur expenses beyond the value of this Agreement. This amendment adds funds in the amount of \$189,000 to the existing Agreement of \$129,190 ending June 30, 2014, so as to compensate Contractor for services to be rendered under this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, County and Contractor agree as follows:

## I. Delete Section A from Exhibit B, Payment Arrangements, and replace with the following:

A. For CONTRACTOR services to be rendered under this contract, CONTRACTOR shall be paid a total contract amount, including cost reimbursements and reserve fund, not to exceed \$318,190 for the July 1, 2013 through June 30, 2014 time period.
