Title: Randall Road Debris Basin Parcel Acquisition

Budget Action: Increase appropriations of \$8,654,000 in Public Works South Coast Flood Zone for Capital Assets funded by a release of Restricted Purpose of Fund balance.

Justification:

In December 2017, and into January 2018, the Thomas Fire severely impacted the watersheds above Montecito and Carpinteria. The resulting 1-9 Debris Flow devastated areas below the fire, including damaging/destroying homes and infrastructure. One of the hard hit areas in Montecito was San Ysidro Creek from the existing debris basin to the ocean. In this area, six homes were completely destroyed on Randall Road along San Ysidro Creek and one property on East Valley Road. A new debris basin project was proposed and received general support by the affected property owners in the area. The project consists of acquisition of seven properties along Randall Road and one property on East Valley Road in Montecito for the purpose of constructing a debris basin along San Ysidro Creek.

This budget revision will allow the Flood Control District to acquire six of those properties. One property was acquired in June of 2019 and one other property is under

The Flood Control District has applied for a FEMA Hazard Mitigation grant which would reimburse 75% of both the property acquisitions as well as

construction of the debris basin.
