**Recommended Action(s):**

That the Board of Supervisors:

- a) Approve the Project and Categorical Exemption pursuant to the County's California Environmental Quality Act (CEQA) for the 2005/06 TEA - 21 Pavement Rehabilitation Project, and
- b) Authorize the Director of Public Works to advertise for construction bids for the 2005/06 TEA-21 Pavement Rehabilitation Project -County Project Number 862260.

**Summary:**

The proposed project sites are located on Hollister Avenue, from the intersection of Modoc Road to approximately 2200 linear feet west of Modoc Road, and the Hollister Avenue and Turnpike Road intersection in the unincorporated area of Goleta. This project will consist of removing and repairing failed areas in the existing pavement, cold planing, placement of a Type B asphalt concrete overlay over a leveling course and a Stress Absorbing Membrane Interlayer (SAMI), painting pavement traffic stripes, markings and installing pavement markers. To ease traffic congestion at the intersection of Hollister Avenue and Turnpike Road, construction work will be performed at night between the hours of 8:00pm to 6:00am.

Pursuant to the County's CEQA guidelines, this project has been determined to be exempt from further environmental review. Approval of the Notice of Exemption shall indicate the Board of Supervisor's approval of this project and will commence the appeal period, pursuant to State CEQA guidelines.

The "Notice to Contractors" will be published prior to the date set for the opening of bids. Sealed proposals to construct this project will be received, opened publicly and read aloud at the County of Santa Barbara, Department of Public Works north and south county offices. Location for south County is 123 E. Anapamu Street, Santa Barbara and the north County office is 620 West Foster Road, Santa Maria, California.



**Background:**

This project is the second phase of road rehabilitation work on Hollister Ave utilizing these TEA-21 funds. The first phase was located at Hollister Avenue, from Turnpike Road intersection to 0.7 miles east of Turnpike Road. The project consisted of removing and repairing of failed areas in the existing pavement, cold planing, placing of pavement reinforcing fabric, an asphalt concrete overlay, painting pavement traffic stripes and marking of County maintained roadway. This project was completed in September 2003.

**Fiscal and Facilities Impacts:**

This project will be allocated through the Transportation Enhancement Activities (TEA-21) a federal program administered by State of California, Department of Transportation which will provide 80% of the cost and Measure "D" will provide the remaining 20%. Funds have been budgeted in Dept. 054, Fund 0015, Program 2900, Org 0022 Account 7510 (TEA - 21) and 7511 (Measure D).

Your Board approved the project as part of the 2005/2006 Capital Improvement Plan, Preventive Maintenance 5-year County-wide Surface Treatment Program, page B-129.
