SUBJECT:	Proposed (1-way) Stop Control at the Intersection of Ivory Drive and Harmony Lane; Fourth Supervisorial District.

RECOMMENDATIONS

That the Board of Supervisors adopt a resolution establishing a one directional stop control at the intersection of Ivory Drive (westbound) and Harmony Lane in the Orcutt area.

ALIGNMENT WITH BOARD STRATEGIC PLAN

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

EXECUTIVE SUMMARY AND DISCUSSION

The intersection of Ivory Drive (westbound) and Harmony Lane is located in the eastern part of Orcutt. These roadways are both local residential streets. The intersection is currently without stop controls in all directions. Vehicles approaching this three-way intersection from Ivory Drive (westbound) and exiting onto Harmony Lane have restricted sight distance looking north and south due to the contour of the roadway and foliage growing along the side of the roadway. Based upon our investigation and the sight distance restrictions at this intersection, it was determined that a one-directional stop control (One-Way), be established on Ivory Drive (westbound). The Public Works Traffic Section has prepared the attached resolution to establish a one-directional stop control at the following intersection:

• On Ivory Drive (westbound) at its intersection with Harmony Lane.
