Title: Increase Appropriations in General County Programs for Sidewalk Vending Pilot Program

Budget Action: Estab Approp of \$12K in Sherriff's GF for S&B funded by an Intrafund Exp Trnsfers(-) from Gen Cnty Progr. Incr Approp of \$42K in Gen Cnty Progr GF for OFU (\$30K) and Intrafund Exp Trsfers (+) (\$12K) funded by a release of Committed Litigation FB. Incr Approp of \$16K in PW Roads-Operations Fund for S&S funded by an op trsfer from the Gen Cnty Progr GF. Incr Approp of \$14K in PH Environ Health Services Fund for S&B funded by an op trsfer from Gen Cnty Progr GF.

Justification: This budget revision is necessary to establish appropriations in the amount of \$42,023 in the General County Program's General Fund to fund the County's Sidewalk Vending Pilot Program. The Pilot Program includes the creation of an interdepartmental enforcement team, the purchase of storage materials for contaminated food and impounded vending equipment, and the development of a public outreach campaign to discourage the public from patronizing unlawful vendors. This budget revision establishes appropriations in General County Programs for operating transfers to the County's interdepartmental enforcement team consisting of County Health (\$13,920), the Sheriff's Office (\$11,985), and Public Works (\$16,118) departments. The source of funding for this Pilot Program is the General County Program General Fund, Committed Litigation fund balance account.
