EXECUTIVE SUMMARY AND DISCUSSION

Helena Street is classified as a minor rural roadway, which runs in the north-south direction in the town of Los Alamos. A request was received from the citizens of Los Alamos to designate a portion of Helena Street as an angle parking zone. This section of roadway is located on the west side of Helena Street north of Bell Street. This section of roadway is 53 feet wide which is more than adequate for an angle parking zone to be established on one side of the street and will provide at least four parking stalls. In response, the Traffic Section will generate a work order to stripe this portion of Helena Street if this resolution is approved by the Board of Supervisors. The Public Works Department recommends the establishment of an angle parking zone at the following location:

On the west side of Helena Street a point 39 feet north of the centerline of Bell Street to a point 91 feet north of the centerline of Bell Street.
