# **Executive Summary and Discussion:**

The County of Santa Barbara and the Solvang Senior Center executed a License and Service Agreement on April 26, 1994, wherein the Senior Center is granted the right to use the county-owned facility to provide certain services and social programs to seniors. The Senior Center is a non-profit organization that serves the senior population in Solvang. They offer hot meals to seniors five days a week, information and referral services, as well as health and educational presentations.

The Senior Center is hosting a Solvang Chamber of Commerce mixer at the Center on July 10, 2003, between the hours of 5:00 p.m. and 7:00 p.m. These mixers have traditionally served beer and wine, however, the License Agreement prohibits the serving of alcoholic beverages at the Center without the written consent of the County.

This Letter of Permission grants the Senior Center the right to serve beer and wine at the July 10, 2003 Chamber of Commerce mixer. No alcohol will be sold at the mixer.
