WHEREAS, the County of Santa Barbara and the Federal Aviation Administration are parties to Federal Airport Improvement Program (AIP) grant 3-06-0243-012-2012 for the Rehabilitation of Taxiway and Taxilane F, and Pedestrian Access Improvement Project at the Santa Ynez Valley Airport; and

WHEREAS, the California Department of Transportation, pursuant to the Public Utilities Code section 21683.1, provides grants equal to 5% of Federal Aviation Administration grants to airports; and

WHEREAS, the California Department of Transportation requires the Board of Supervisors to adopt a resolution authorizing the submission of an application for AIP Matching grant;

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of the County of Santa Barbara, State of California:

1. Authorizes filing an application for a state AIP Matching grant for this project.
2. Authorizes accepting the allocation of state AIP Matching funds for the project.
3. Authorizes execution of an AIP Matching Grant Agreement for this project; and

BE IT FURTHER RESOLVED, that the Board of Supervisors of the County of Santa Barbara does hereby authorize Santa Barbara County Director of General Services, Robert Nisbet to sign any documents required to apply for and accept these subject funds

for the Rehabilitation of Taxiway and Taxilane F, and Pedestrian Access Improvement Project at the Santa Ynez Valley Airport on behalf of the County of Santa Barbara.


