#### **Recommendations:**

That the Board of Supervisors execute, in duplicate, a <u>Lease Agreement</u> between the County of Santa Barbara and Santa Ynez Valley People Helping People, a non-profit Corporation, for 663 square feet of office space at 545 Alisal Road, Suites 109, 110 and 111, in the City of Solvang to be occupied by the Public Health Department/WIC Nutrition Services Program. The lease term is July 1, 2006 through June 30, 2007 and the rent is \$356.92 monthly. The agreement also grants to the Director of Public Health the authority to exercise annual renewal options and if renewed, the rent will be adjusted by ½ of the CPI, but not more than 2%.

### **Alignment with Board Strategic Plan:**

The recommendation(s) are primarily aligned with Goal No. 2. A Safe and Healthy Community in Which to Live, Work, and Visit and with actions required by law or by routine business necessity.

### **Executive Summary and Discussion:**

The original lease with People Helping People was executed by the Board on June 25, 1996. At that time the Public Health Department ran an office and immunization clinic at this location as well as the WIC Nutrition Services Program. In June of 2003, the clinic ceased operations and vacated the premises, but the WIC Program wished to remain in the premises. On July 1, 2003, a 12A10 lease was approved by the General Services Director on behalf of the Board for a lease term of 3 years. This agreement is scheduled to expire on June 30, 2006. The Public Health Department/WIC Nutrition Services Program has funding for the 2006-07 fiscal year and would like to continue to provide services to the citizens of Solvang and the Santa Ynez Valley. This Agreement

provides the Director of Public Health Services the ability to renew the lease annually if the department has the necessary funding available without necessitating the timely process to generate a new lease.
