Recommended Actions:

- A. Approve and execute the attached original and duplicate easement purchase contract with Craig G. Johnson and Judy C. Johnson (owners) for purchase of an easement over a portion of owners' property known as Assessor's Parcel Number (APN) 023-091-020 in the amount of \$5,750.00 in connection with an existing lift station located on Vista Elevada in the Mission Canyon area.
- B. Accept the attached permanent easement deed to the real property conveyed from Craig G. Johnson and Judy C. Johnson (owners) to the County of Santa Barbara for an easement on a portion of APN 023-091-020 by authorizing the Clerk of the Board to sign the certificate of acceptance attached thereto.
- C. Accept the attached permanent easement deed to the real property conveyed from Marilyn D. Anticouni (owner) to the County of Santa Barbara for an easement on a

portion of APN 023-091-007 by authorizing the Clerk of the Board to sign the certificate of acceptance attached thereto.

- D. Approve a budget revision to appropriate \$5,750.00 from County Service Area 12 reserves for acquisition of the easement on APN 023-091-020.
- E. Find that the proposed actions do not constitute a "Project" within the meaning of the California Quality Act (CEQA), pursuant to 14 CCR 15378 (b)(5), in that it is a government administrative activity that will not result in direct or indirect changes in the environment.

Summary Text:

Acquisition of the two easements will establish rights of way for the existing Vista Elevada lift station which serves residents of County Service Area (CSA) 12 in the Mission Canyon area.

Background:

County Service Area (CSA) 12 (Mission Canyon Sewer District) was formed in 1984 to provide wastewater collection services for residents of Mission Canyon. The City of Santa Barbara provides operation and maintenance services of certain facilities in CSA 12 and also provides for the treatment and disposal of wastewater pursuant to Joint Powers Agreement No. 12,554 dated October 2, 1984. These services include the operation and maintenance of two lift stations located on Vista Elevada and Andante Road.

Recent improvements to the City's control and alarm system included the installation of a new control panel at the Vista Elevada site. These improvements allow for City staff to monitor and control lift station functions remotely. To locate the panel, a survey was performed to confirm available boundaries for its placement. Upon review of the survey, it was determined that some of the existing lift station improvements constructed in 1986 had been installed beyond the limits of the original sewer easement on two parcels. The easement on APN 023-091-020 is 177 square feet while the easement on APN 023-091-007 is 61 square feet. This action provides for easements on these parcels to appropriately house the infrastructure footprint.

Performance Measure:

The cost for the easement on APN 023-091-020 is \$5,750.00 while owner of APN 023-091-007 is providing the easement on that parcel at no cost.
