## AN ORDINANCE AMENDING ORDINANCE NO. 4832, THE AGRICULTURAL COMMISSIONER'S FEE SCHEDULE

THE BOARD OF SUPERVISORS OF THE COUNTY OF SANTA BARBARA, STATE OF CALIFORNIA, ORDAINS AS FOLLOWS:

#### **SECTION 1:** Findings.

The "Whereas" section of Ordinance No. 4832, The Agricultural Commissioner's Fee Schedule, is hereby amended to add the following additional findings:

WHEREAS, on June 15, 2010, the Board of Supervisors for the County of Santa Barbara adopted Ordinance No. 4751, An Ordinance Amending the Agricultural Commissioner's Fee Schedule, which updated the hourly rate for the department to \$80 per hour, the current rate used by the department; and

WHEREAS, on April 10, 2012, the Board of Supervisors for the County of Santa Barbara adopted Ordinance No. 4832, An Ordinance Amending the Agricultural Commissioner's Fee Schedule, to update the fee schedule to include weights and measure fees and repealed Ordinance No. 4751; and

WHEREAS, MGT conducted a fee analysis of the Agricultural Commissioner's Office, which is attached to the August 24, 2021 Board Agenda Letter, to determine the reasonable cost for the Agricultural Commissioner's Office to provide required services, inspections and certifications, and determined that the hourly rate for the Agricultural Commissioner's staff time should be updated to \$130 per hour during normal working hours and \$195 per hour for overtime work outside of normal working hours; and

WHEREAS, the proposed fees are directly related to the cost reasonably necessary to provide services of the Agricultural Commissioner's Office; and

WHEREAS, pursuant to California Government Code Section 50076 and California Constitution Article XIIIC, Section 1, subdivision (e)(1), (2) and (3), a fee for inspections, certifications, registrations, and other services provided by the Agricultural Commissioner's office may be charged by the local government provided that it does not exceed the reasonable cost of providing the service or regulatory activity for which the fee is charged; and

WHEREAS, on September 12, 2021, the County held a public hearing on the proposed Agricultural Commissioner Office fee update as part of a regularly scheduled meeting of the Board; and

WHEREAS, the Board finds that the fees set forth in this Ordinance are exempt from CEQA review pursuant to 14 CCR §§ 15273 and 15378(b)(4) and Public Resources Code Section 21080(b)(8)(A) and (B), in that the fees will be used for operating expenses, reimbursement for staff and consultants time and costs, etc.; and

WHEREAS, the Board hereby updates and sets the fees for the Agricultural Commissioner's Office in the attached Fee Schedule, as determined to be reasonable by said fee analysis.

\* The hourly rate fees set forth in Exhibit A shall be reviewed annually by the Agricultural Commissioner and may be adjusted pursuant to changes in the Consumer Price Index based on all urban consumers, Los Angeles-Riverside-Orange County area. Adjustments shall be rounded to the nearest dollar and become effective no earlier than June 1<sup>st</sup> each year and appropriate notice shall be provided to the pubic 30 days prior to the effective date of the adjustment.

#### **SECTION 3: Updated Attachments.**

#### **SECTION 4.** Remainder of Ordinance No. 4832 Unchanged.

Except as amended by this Ordinance, Ordinance No. 4832, An Ordinance Amending the Agricultural Commissioner's Fee Schedule, shall remain unchanged and shall continue in full force and effect.

#### **SECTION 5**: Severability.

If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this Ordinance. The Board of Supervisors hereby declares that it would have passed this Ordinance and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses, or phrases be declared invalid.

#### **SECTION 6:** Effective and Operative Date.

This Ordinance shall take effect and be in force 30 days from the date of its adoption by the Board of Supervisors and before the expiration of 15 days after its passage a summary of it shall be published once together with the names of the members of the Board of Supervisors voting for and

Weights & Measures Device, Point of Sale System, Packer Registration, and California Department of Food and Agriculture administrative fees (amended).

- I. The annual registration fee for a business that uses a commercial weighing or measuring device or devices shall be assessed the maximun fees set forth in Business and Professions Code section 12240 and shall consist of a business location fee, a device fee, and a Department of Food and Agriculture administrative fee as authorized by Business and Professions Code section 12241 and set forth in 4 CCR §4075. The current business location fee and device fee are the following:\*\*
  - (a) A business location fee of one hundred dollars (\$100) per business location, plus the applicable device fee listed in subdivisions (b) to (n), inclusive.
  - (b) For marinas, mobilehome parks, recreational vehicle parks, and apartment complexes, where the owner of the marina, park, or complex owns and is responsible for the utility meters, the device fee shall not exceed the following:
    - (1) For water submeters, two dollars (\$2) per device per space or apartment.
    - (2) For electric submeters, three dollars (\$3) per device per space or apartment.
    - (3) For vapor submeters, four dollars (\$4) per device per space or apartment.

- (c) For weighing devices, other than livestock scales, with capacities of 10,000 pounds or greater, the device fee shall be two hundred fifty dollars (\$250) per device; for weighing devices, other than livestock scales, with capacities of at least 2,000 pounds but less than 10,000 pounds, the device fee shall be one hundred fifty dollars (\$150) per device.
- (d) For livestock scales with capacities of 10,000 pounds or greater, the device fee shall be one hundred fifty dollars (\$150) per device; for livestock scales with capacities of at least 2,000 pounds but less than 10,000 pounds, the device fee shall be one hundred dollars (\$100) per device.
- (e) Farm milk tanks are exempt from registration certificate requirements and all annual registration fees.
- (f) A scale or device used in a certified farmers' market, as defined by Section 113745 of the Health and Safety Code, is not required to be registered in the county where the market is conducted, if the scale or device has an unexpired seal for the current year, issued by a licensed California county sealer. Any resident of Santa Barbara County that brings a scale or device used in a certified farmers' market to a location specified by the office of weights and measures for testing shall be exempt from paying a business location fee for that device.
- (g) (1) For liquefied petroleum gas (LPG) meters, truck mounted or stationary, the device fee shall be one hundred seventy-five dollars (\$185) per device.
- (2) For compressed natural gas (CNG) and liquified natural gas (LNG) meters, truck mounted or stationary, the device fee shall not exceed one hundred eighty-five dollars (\$185) per device beginning in 2021.
- (h) For wholesale and vehicle meters, the device fee shall be twenty-five dollars (\$75) per device.
- (i)For computing scales, the device fee shall not exceed twenty-three dollars (\$23) per device. For purposes of this subdivision, a computing scale shall be a weighing device with a capacity of less than 100 pounds that indicates the money value of any commodity weighed, at predetermined unit prices, throughout all or part of the weighing range of the scale. For purposes of this subdivision, the portion of the annual registration fee consisting of the business location fee and the device fees authorized by this subdivision shall not exceed the sum of one thousand dollars (\$1,000) for each business location.
- (j) For jewelry and prescription scales and scales marked as, or meeting the design and performance requirements of, a Class II weighing device, the device fee shall not exceed eighty dollars (\$80) per device. For purposes of this subdivision, a jewelry or prescription scale or a scale marked as, or meeting the design and performance requirements of, a Class II weighing device shall be a scale that meets the specifications, tolerances, and sensitivity requirements established or adopted by the secretary applicable to those devices in accordance with Section 12107.

- (k) For weighing devices, other than computing, jewelry, and prescription scales and scales marked as, or meeting the design and performance requirements of, a Class II weighing device, as defined in subdivisions (n) and (o), with capacities of at least 100 pounds but less than 2,000 pounds, the device fee shall not exceed fifty dollars (\$50) per device.
- (1) For vehicle odometers utilized to charge mileage usage fees in vehicle rental transactions or in computing other charges for service, including, but not limited to, ambulance, towing, or limousine services, the device fee shall not exceed sixty dollars (\$60) per device.
- (m) For vehicle odometers utilized to charge mileage usage fees in vehicle rental transactions involving non-passenger vehicles that are not subject to Chapter 1.5 (commencing with Section 1939.01) of Title 5 of Part 4 of Division 3 of the Civil Code, the portion of the annual registration fee consisting of the business location fee and the device fee authorized pursuant to subdivision (q) shall not exceed the sum of three hundred forty dollars (\$340) for each business location.
- (n) For all other commercial weighing or measuring devices not listed in subdivisions (b) to (m), inclusive, the device fee shall be twenty dollars (\$20) per device. For the purposes of this subdivision, the total annual registration fee shall not exceed the sum of one thousand dollars (\$1,000) for each business location.
- II. The annual registration fee for each location with point of sale systems shall consist of a device fee with no location fee and no Department of Food and Agriculture administrative fee. Pursuant to Business and Professions Code section 13350, the following fees shall apply:

The CDFA administrative fees set forth above are subject to adoption and subsequent amendment by the California Department of Food and Agriculture, and, as required by law, shall be collected by the County office of weights and measures in the manner specified in 4 CCR §4075.

- \* Starting in FY24/25, the hourly rate fees set forth in Exhibit A shall be reviewed annually by the Agricultural Commissioner and may be adjusted pursuant to changes in the Consumer Price Index based on all urban consumers, Los Angeles-Riverside-Orange County area. Adjustments shall be rounded to the nearest dollar and become effective no earlier than June 1<sup>st</sup> each year and appropriate notice shall be provided to the pubic 30 days prior to the effective date of the adjustment.

- \*\*\* Fees will be phased in as follows: fees noted FY 21/22 or noted "changed" will become effective on the effective date of this ordinance. Fees noted FY 22/23 will become effective July 1, 2022. Fees noted FY 23/24 will become effective July 1, 2023.
