SUBJECT: Post September 11 Funding Reimbursement

That the Board of Supervisors authorize the County Administrator to submit a reimbursement claim to the California Victim Compensation and Government Claims Board for certain activities conducted as a result of September 11th terrorist attacks on the World Trade Center, the Pentagon and Pennsylvania.

Executive Summary and Discussion:

As a result of the tragic events of September 11, 2001, the Governor signed Senate Bill 551, a measure to assist Counties and all Californians affected by the terrorist attacks. This bill provides reimbursement funding to Counties for the costs of providing group mental health counseling and education or activities to promote tolerance for individuals who may be at risk for discrimination as a result of terrorism.

The reimbursement covers any cost of tolerance promotion activities conducted between September 11, 2001 through July 2, 2002.

The County conducted a variety of activities related to tolerance promotion and education. (Attachment A) Reimbursement would allow us to recoup already expended resources.

If additional activities are conducted by July 2, 2002 we will seek reimbursement for those expenses accordingly.
