the Goleta Water District.

Summary Text:

The County is replacing the water main in the 6500 block of Trigo Road in Isla Vista as a condition for water service at the new Isla Vista Foot Patrol building at 6504 Trigo Road. This agreement accompanies a surety deposit of \$262,500 that is required by the Goleta Water District to ensure that funds are available to complete the water main replacement in case the County does not finish the job to Goleta Water's plans and specifications. The deposit will be returned in stages as the project progresses. One third of the deposit (\$87,500) will be returned on the Date of Acceptance that the project is complete. One third of deposit will be returned 90 days after the Date of Acceptance. The final third will be returned one year after the date of acceptance. Interest on the funds deposited will also be paid the County.

Background: As a condition of building the new Isla Vista Foot Patrol station at 6504 Trigo Road, Goleta Water District is requiring the County to replace the existing four inch water main at the 6500 block of Trigo with an eight inch main to ensure that adequate water service is available for the facility. Domestic, fire protection and fire hydrant services were added to this section of Trigo Road with the construction of the station, requiring the upgrading of the water main.
