That the Board of Supervisors:

Adopt a resolution effective July 31, 2006, as follows:

ESTABLISH JOB CLASSIFICATION

Firefighter, Trainee (Class 3574), Range 5490 (\$3,750-\$4,578 per month)

FIRE DEPARTMENT (#3710)

Reallocate positions

From: Firefighter Staff/Shift (Classes 3575/3576)

To: Firefighter Trainee/Staff/Shift (Classes (3574/3575/3576)

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 3. A Strong Professionally Managed County Organization.

Executive Summary and Discussion:

This recommendation establishes a non-safety, trainee job classification for employees who have not yet completed all of the requirements to qualify as a Firefighter, including the Fire Department's Recruit Academy. The new job classification will allow the Fire Department increase paramedic coverage and workforce diversity. Positions in this classification may promote to Firefighter upon successful completion of the Recruit Academy and possession of required Emergency Medical Technician license(s).

Mandates and Service Levels:

No change in programs or service levels.

Fiscal Impact:

The Fire Department expects to save approximately \$2,280 per trainee while the employee is attending the Recruit Academy. Based on an estimated hiring of 6 trainees per year, this will result in an annual savings of approximately \$13,680.
