#### Summary Text:

The recommended Board actions are on the agenda to award an Agreement for Services of Independent Contractor to Langan CA, Inc. to perform environmental services to evaluate air quality, including building survey and indoor air and ambient air sampling.

## **Background:**

The County property located at 1112 Santa Barabara Street, Santa Barbara, CA (Site) has nearby sites that have been historically impacted by solvent contamination (mainly, tetrachloroethylene, also known as "PCE" and "perc"). Those nearby sites have implemented source area remediation under the oversight of the Central Coast Regional Water Quality Control Board ("Water Board"). The indoor air assessment of the County Site is a precautionary measure and not under requirement from the Water Board.

Langan CA, Inc. will provide a range of environmental services to evaluate indoor air quality at the Site and make recommendations for mitigation, if any, based on findings.

### Fiscal and Facilities Impacts:

Funding for this one-time professional service contract, with a one-year term, is budgeted in FY 2024-25 and costs are anticipated to extend into FY 2025-26. The services will be funded by the General Services General Fund 0001 Environmental Compliance Services line item.
