Appropriation For A Non-Cash Donation of a UTV, trailer, and firing equipment for the Fire Dept.

Budget Action: Establish appropriations of \$52,506 in Fire Department Fire Protection District Fund for Capital Assets (\$35,299) and Services and Supplies (\$17,207) funded by

unanticipated revenue from Other-Capital Donations.

Justification:

In November of 2021, the Santa Barbara County Fire Protection District submitted a donation request to the Santa Barbara Firefighters Alliance for the purchase of a UTV with trailer, valued at \$35,299 for County Fire Station 38 in Gaviota and 12 Initial Attack Kits with Launchers, valued at \$17,207, for use during firing operations. In December of 2021, the Alliance generously approved the request.

Local residents and visitors to Santa Barbara County will benefit from the UTV and trailer at FS38. Station 38's district (Gaviota) contains steep, challenging terrain with few paved roads. Hiking, biking, or jeep trails traverse the area and are often times the best and/or only access in the event of an emergency. The UTV is an excellent piece of equipment to make access to the aforementioned areas in an emergency. Currently, the closest UTV to Station 38 is over 20 minutes away.

In addition, the equipment from Firequick Products, Inc. allows firefighters to engage in critical firing operations from a safe location.
