RESOLUTION NO:

WHEREAS, the Santa Barbara County Board of Supervisors has previously entered into an agreement with the California Victim Compensation Board (CalVCB) and desires to continue participating in the California Criminal Restitution Compact (CRC) program to ensure that restitution fines and orders are properly administered in accordance with applicable statutes.

NOW, THEREFORE, BE IT RESOLVED that this Resolution authorizes the District Attorney or designee to accept and expend grant funds in the amount of \$297,792.00 from CalVCB for the period of July 1, 2026 through June 30, 2029 to implement the CRC program subject to the execution of a Standard Agreement and acknowledgment of the terms and conditions contained therein, including any amendments to the Standard Agreement extending the term thereof through December 30, 2029, or for a supplemental grant award in the amount not to exceed \$50,000 annually.

NOW, THEREFORE, BE IT RESOLVED that the District Attorney of the County of Santa Barbara, or designee, is authorized to submit the attached Standard agreement S26-016 to CalVCB, and is authorized to execute on behalf of the Board of Supervisors the Standard Agreement.




