SUBJECT: **Serenidad Interceptor Channel Project Completion (SC8318),
Second Supervisorial District**

Recommendation(s):

That the Board of Directors:

- A. Accept the attached Notice of Completion for the Serenidad Interceptor Channel Project and authorize the Clerk to record; and
- B. Adopt the Resolution establishing the final quantities for work performed and materials supplied for the Serenidad Interceptor Channel Project by the contractor Spiess Construction Company Inc. Contractors (a local vendor) in the amount of \$229,139.75.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 2. A Safe and Healthy Community in Which to Live, Work, and Visit.

Executive Summary and Discussion:

On May 27, 2003, your Board entered into an agreement with Spiess Construction Company Inc. for the construction of the Serenidad Interceptor Channel Project in the amount of \$221,640.00.

The Serenidad Interceptor Channel Project is located by Serenidad Place in the City of Goleta. This project consisted of constructing an access ramp and a 6-foot wide concrete interceptor channel behind several homes in the vicinity. This new channel replaced an existing concrete "V" ditch channel that has not worked adequately during previous storm events. This project will increase capacity for flood generated debris and will also allow for improved maintenance by providing access for equipment.

The District has accepted the work of the contractor, Spiess Construction Company Inc. completed per plans and specifications. The project was completed at a cost of \$229,139.71.

Mandates and Service Levels:

This project will increase flood control benefits for the surrounding area. In addition, this project provides for improved access for equipment for maintenance of the channel. This will reduce maintenance costs associated with debris removal of the facility. Previously, maintenance of the channel was done by hand due to limited access for equipment.

Fiscal and Facilities Impacts:

This project was included in the Adopted 2003/04 Budget and costs were allocated in the Design Cost Center under the Water Resources Division of the Public Works Department as shown on page D-322 in the budget book. Costs from this project are being paid from Dept: 054, Acct: 8700, Fund: 2610, Program: 3005. This project is also identified in the County's Capital Improvement Plan.
