CSD/CEO - Rec Master Plan - Cannabis and Equity funded portion

Budget Action: Inc appr. of \$120,000 in Community Services Department (CSD) General Fund for Services and Supplies (\$120,000) funded by an Intrafund transfer from General County Programs (GCP). Transfer appr. of \$120,000 in General County Programs, General Fund from Services and Supplies to Intrafund Expenditure Transfers (+) for

Parks Rec Master Plan.

Justification:

Community Services is seeking Board direction on expanding the original Countywide Recreation Master Plan scope to include planning and drafting of Comprehensive Plan, community plan, and zoning ordinance amendments, environmental review of those amendments, and processing of those amendments by the Planning and Development Department. Funded by the Board's June Budget Hearing set-aside of \$3.5M for North and South County Parks, Trails and Open Spaces (\$80,000, \$40,000 from each North and South allocation) and the County Equity set-aside funds (\$40,000) for anticipated costs to be incurred during the remainder of FY21/22.

Total anticipated costs are estimated to be up \$490,000 to fund staff time for Planning and Development and staff, fees, and consultant costs for Community Services. Based on past experience, Planning and Development has estimated that its Department's cost to review and process zoning ordinance. Comprehensive Plan, and community plan amendments proposed through the Recreation Master Plan process could be up to \$270,000 over two years. Community Services would require \$220,000 to act as the applicant submitting amendments, to pay for various filing requirements, and to fund consultant services to draft the zoning ordinance. Comprehensive plan and community plan amendments, analyze those amendments in the Program EIR, and analyze recreational project types in the Program EIR.

Remaining allocations totaling \$370,000 will be budgeted in FY22/23.
