Recommendations:

- a. That the Board of Supervisors approve and authorize the Chair to execute Amendment No. 4, a CREDIT amount of (\$17,143), to the construction contract 04-182 with S.J. Deferville Construction, Inc. (a local vendor) for construction change orders associated with the Public Works Service Center, Project #8643, for a revised Contract total of \$2,447,563.
- b. That the Board of Supervisors approve the Notice of Completion for the Public Works Service Center, Project #8643, located at 620 W. Foster, Santa Maria.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 2 Ensure the Public Health and Safety and Provide Essential Infrastructure.

Executive Summary and Discussion:

On March 16, 2004, the Board executed a construction contract in the amount of \$2,174,408 to S.J. Deferville Construction, Inc. of Santa Maria, CA, for approximately 11,500 square feet of office and public space for Public Works functions, including Water Resources, Disaster Recovery, Permits, Construction, Sanitation, Transportation, Solid Waste and Surveys.

The total change order in this Contract Amendment is a (-\$17,143) **Credit.** The majority of the change order is a (-\$28,400) Credit for Gravel at Parking Lots deleted from the scope and \$8,800 Drywall/Painting due to Enlarged Ducts. The remainder of the Contract Amendment items includes a Credit for Trees deleted from the scope, installation of new Parking Lot Light Fixtures on Existing Poles, and Fabrication & Installation of Handrails at Steps.

Contract Amendment No.1 equaled \$69,695 and was under the threshold allowing approval by the Directors of General Services and Public Works. Contract Amendment No. 2 equaled \$69,745. Contract Amendment No. 3 equaled \$150,858. With Amendment No. 4 equaling -\$17,143, the changes to date total \$273,155.

The project was completed on January 24, 2006, for the total contract amount of \$2,447,563, which is inclusive of the original contract amount and all four amendments as shown above. There are no claims outstanding and final retention payment has been made to the contractor.

Mandates and Service Levels:

No change in service level.

Fiscal and Facilities Impacts:

The project is fully funded. Various Public Works funds will reimburse Capital Outlay for the funds allocated to design and construct this project. Funds for this contract have been appropriated and are available in Fund 2870, Dept. 054, Line Item 6000, Program Foster/Admin, Project 8643. It is shown in the Public Works' Department Summary as *Capital Improvements* on page D-308 of the Santa Barbara County Budget for FY 2005-2006. The \$10,000/month savings from existing lease costs will offset reimbursement of the Capital Outlay.
