Title:

Increase Social Services positions by 10 to manage the expansion of the CalWorks program

Budget Action: Increase appropriations by \$1,438,619 in the Social Services Department within the Social Services Fund for Salaries and Employee Benefits (\$538,619) and Services and Supplies (\$900,000) funded by unanticipated Federal revenue of \$1,222,826 and unanticipated State revenue of \$215,793.

Justification:

Recent CalWORKs reforms established a prospective 24-month time limit on cash assistance and employment services for adults. Under existing law, with certain exceptions, every individual, as a condition of eligibility for aid under the CalWORKs program, is required to participate in welfare-to-work activities. Existing law requires recipients who are not exempt to participate in job search and job club. With this 24-month time limit, it is imperative that program recipients are receiving exceptional service to maximize their chances of finding, and keeping, employment.

The additional positions are necessary for DSS to implement the expansion and enhancement of employment services and job development activities for program participants and to intensify case management efforts for non-participating individuals.

The total cost of \$1.4M for the period November, 2013 through June 2014 will be funded with 85% Federal and 15% State funds. No additional County funds are required. Ongoing annual cost will be \$1.7M and will be funded with 85% Federal and 15% State funds. No additional County funds are required.
