

NOTICE OF EXEMPTION

PROJECT DESCRIPTION: The contract award is for the amount of \$2,419,218. 00 for a previously approved project. The award of the construction contract goes to the lowest responsible bidder, Valley Slurry Seal Company of West Sacramento, CA. This exemption considers all further administrative activities, including the Statement of Final Quantities for project close out. The proposed project activity is located County-wide, in all Supervisorial Districts of Santa Barbara County.


