**WHEREAS**, The location and dates of the Santa Barbara County Board of Supervisors’ meetings shall be established, and amended, by Resolution of the Board of Supervisors; and

**WHEREAS**, The regular meetings of the Santa Barbara County Board of Supervisors shall generally be held on the first three Tuesdays of every calendar month at 9:00 A.M., with the exception of a Tuesday following a Monday holiday; and

**WHEREAS**, The Santa Barbara hearing room is located at 105 East Anapamu Street, Santa Barbara and the Santa Maria hearing room is located at 511 East Lakeside Parkway, Santa Maria; and

**WHEREAS**, The Board of Supervisors may recess for a consecutive four-week period generally during the last two weeks in July through the first two weeks in August, although the Board may convene during that time, as needed; and

**WHEREAS**, The 2024 Board of Supervisors Schedule of Meeting includes 28 Regular Meetings of the Board of Supervisors as well as Budget Workshops and Budget Hearings. At the discretion of the Board of Supervisors, meetings can be added or cancelled throughout the year as necessary; and

**WHEREAS**, The 2024 schedule incorporates a Summer Recess from July 23, 2024 through August 13, 2024 and a Winter Recess from December 17, 2024 through December 31, 2024. The proposed recesses maintain two Board of Supervisors meetings a month in July, August, and December 2024; and

**WHEREAS**, The members of the Board of Supervisors are also ex officio members of the Boards of a number of Dependent Districts. Dependent Districts may hold hearings at any of the locations and dates identified in the Board of Supervisors Resolution; and

**NOW, THEREFORE, BE IT HEREBY ORDERED AND RESOLVED** by the Board of Supervisors of the County of Santa Barbara, acting as the governing body of the County of Santa Barbara, approve the 2024 Board of Supervisors Schedule of Meeting Dates and Locations as reflected on page 2 of this Resolution.
