Santa Barbara Board of Supervisors,

As a teacher at Goleta Valley Junior High, I'm acutely aware of the challenges faced by our farming families. It's disheartening to witness how vulnerable they can be to the whims of the market and the unpredictability of the weather. Their livelihoods often hang by a thread, subject to forces beyond their control. I'm writing to you today because I believe the Agricultural Enterprise Ordinance offers a unique opportunity to bolster their livelihoods.

This ordinance opens exciting possibilities for farms to stabilize their income through innovations like farm stays and agritourism. Imagine people learning firsthand where their food comes from while forging a connection with the land. It's not only educational, it brings in much-needed revenue that helps our farmers thrive.

The planning commission discussed increasing the allowed owner accommodations to 60% per parcel. I'm sure you'll say that any higher is excessive, that it could lead to overcrowding or disrupt the rural character of our community. You'll likely worry about the potential strain on infrastructure or a perceived shift away from traditional agricultural practices. Is it impossible to change the owner accommodation allowance to 80%?

Without sufficient opportunities, we risk losing these farms to larger corporations, forever altering the landscape of Goleta Valley. That's a loss we simply cannot afford.

I believe we share a common goal: to cultivate a thriving and sustainable agricultural community for generations to come. These changes would be a powerful demonstration of our commitment to that shared vision.
