SUBJECT: Construction of County Wide 2002/2003 Measure "D" Misc. Concrete Repair, Tree Root Pruning & Shielding, in the First, Second, Third and Fourth Supervisorial Districts. Santa Barbara County Project Number 820491.

Recommendation(s):

That the Board of Supervisors:

Review and approve the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor, Granite Construction Company, Inc. (a local vendor), Post Office Box 6744, Santa Barbara, California 93160, in the amount of \$1,015,333.08.

Alignment with Board Strategic Plan:

The recommendation is primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effective to the Needs of the Community.

Executive Summary and Discussion:

This project consisted of removing and repairing approximately 1,950 square yards of damaged areas in the existing pavement, removing and replacing approximately 13,178 linear feet of damaged curb, gutter, and sidewalk, 89 curb ramps, and approximately 3,925 linear feet of tree root pruning and shielding. This contract was accepted as complete, by the Director of Public Works on June 18, 2003.

This project was completed on time and under the budgeted contract amount.
