Justification: On August 12, 2022 the Community Corrections Partnership (CCP) approved a one-time allocation to fund the Sheriff's Office Freedom to Choose jail pilot program funded by Public Safety Realignment reserve funds from Probation. The program addresses unhealthy behaviors by custody inmates while providing

tools to improve coping mechanisms and strengthening prosocial behavior.

On December 2, 2022 the CCP approved a one-time allocation to fund the Sheriff's Office Onsite Solar Training Program funded by Public Safety Realignment reserve funds from Probation. The objective of the program is for participants to gain skills required for entry level positions in the solar industry.

This Budget Revision is to recognize the remaining 50% (\$15,000) of the cost of the Freedom to Choose program and to recognize the cost (\$139,520) of GRID Alternative Solar Training by increasing appropriation in the Sheriff's Office General Fund for Professional Services funded by an Intrafund Expenditure Transfer from the Probation Department General Fund. The initial \$15,000 was included on BJE - 0008798 and fully expended in FY22-23.
