WHEREAS, California Vehicle Code Sections 22507 and 22651(n) and the Code of Santa Barbara County, California, Section 23-11, authorize the Board of Supervisors of the County, to establish "No Parking-Tow Away" zones on portions of roads and highways under its jurisdiction; and

WHEREAS, it is in the best interest of public health and safety that certain portions of County highways in Santa Barbara County be designated as no parking-tow away zones during a "Red Flag Warning", in accordance with said Sections; and

WHEREAS, during extreme fire risk conditions, the parking of vehicles on certain shoulder areas may compromise public safety in the event of a fire emergency; and

WHEREAS, meteorologist at the National Weather Service or the Fire Chiefs of Santa Barbara County may declare a "Red Flag Warning" when they believe that the fire danger is extreme based on high winds, low humidity, and warm temperatures; and

WHEREAS, the Board finds that protection of public health and safety will be improved by the establishment of "No Parking-Tow Away" zones on portions of East Mountain Drive and Riven Rock Road; and

WHEREAS, signs or markings giving adequate notice of "Red Flag Warnings" and parking restrictions will be placed only at locations approved by the Board of Supervisors; and

**NOW THEREFORE, IT IS RESOLVED AND ORDERED,** that the following locations in Santa Barbara County and under the jurisdiction of the Board of Supervisors of said County are hereby designated as "No Parking-Tow Away during Red Flag Warning":

## No Parking-Tow Away during Red Flag Warning

- EAST MOUNTAIN DRIVE, from a point 335 feet west of the centerline of Ashley Road to the centerline of Hot Springs Road.
- RIVEN ROCK ROAD, from a point 385 feet south of the centerline of East Mountain Drive to the centerline of East Mountain Drive.

IT IS FURTHER RESOLVED that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to install appropriate markings and/or signs at said location as time and resources permit.
