

# AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

between

COUNTY OF SANTA BARBARA  
AND  
GOOD SAMARITAN

## FIRST AMENDMENT

This is the First Amendment (hereinafter referred to as First Amendment to Agreement) for Case Management Supportive Services, BC 20048 (hereinafter Agreement) by and between the County of Santa Barbara, (“COUNTY”) and Good Samaritan (“CONTRACTOR”), with an address of 245 E. Inger St., Suite 103B, Santa Maria, CA 93454.

### RECITALS

**WHEREAS**, COUNTY and CONTRACTOR originally executed Agreement for use of funds through the Judicial Council of California on June 16, 2020, with a time of performance effective as of June 1, 2020 and ending December 31, 2021; and

**WHEREAS**, COUNTY and CONTRACTOR wish to extend the end date of the Agreement to June 30, 2022; and

**WHEREAS**, COUNTY agreed to pay CONTRACTOR a total contract amount, including cost reimbursements not to exceed the sum of Two Hundred and Forty Thousand dollars (\$240,000) for rendered services pursuant to the contract; and

**WHEREAS**, COUNTY and CONTRACTOR desire to increase the contract amount by adding \$84,700.00 of additional funding to the budget of Agreement as set forth in Payment Arrangement, Attachment B-1 to Exhibit B; and

**WHEREAS**, any grant funds not expended by December 31, 2021, will be available until June 30, 2022, to spend or encumber for the PROJECT; and

**WHEREAS**, This First Amendment incorporates the terms and conditions set forth in the Agreement approved by the County Board of Supervisors on, June 16, 2020, BC-20048;

**NOW THEREFORE**, the Agreement is amended as follows:

1. Paragraph 4. TERM of the Agreement, is hereby amended as follows:

CONTRACTOR shall commence performance on June 1, 2020, and end performance upon completion, but no later June 30, 2022, unless otherwise directed by COUNTY or unless earlier terminated.

2. Paragraph 5. COMPENSATION OF CONTRACTOR, Exhibit B PAYMENT ARRANGMENTS, paragraph A. of the AGREEMENT, is amended as follows:

A. For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed **\$324,700**.

3. ATTACHMENT B-1 SCHEDULE OF FEES, of Exhibit B, of the Agreement is hereby deleted and replaced with AMENDED ATTACHMENT B-1, SCHEDULE OF FEES as follows:

5. This First Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.


